Tuition Fee Schedule 2018/19

The tuition fees which will be charged by UCA for the 2018/19 academic year are shown on the following page. These should be read in conjunction with the notes below and the UCA Fee Regulations which can be found on our website.

Note 1

These fee rates are valid for the 2018/19 academic year only and are subject to increase in future academic years, including during continued registration. The fees stated for subsequent years of study do not serve as a guide as to what the fee level for that year of study might be in future academic years, as course fee structures change from time to time. Where fee adjustments are made year-on-year on-course to take account of inflation, this adjustment will be at or below the RPI-X forecast rate as advised by the independent Office for Budget Responsibility (OBR) and the Office for Fair Access (OFFA).

Note 1a

Fees regulated by the government are subject to changes in legislation and may change from time to time. This schedule will be updated as appropriate should changes in government policy lead to amended fee rates.

Note 2

For overseas students first registering in or after 2015/16: Overseas students progressing from a Further Education course (including International Foundation in Art, Design & Media (IFADM)) to an Undergraduate course, from an Undergraduate course (including the Graduate Diploma in Art & Design (GDAD)) to a Taught Postgraduate course, or from a Taught Postgraduate course to a Postgraduate Research course will be eligible for a 10% discount on the standard listed tuition fee for the first academic year of the course on to which they are progressing. If the student pays the discounted progression fee in full prior to enrolment then they will also be entitled to a 4% discount on the discounted progression fee. See individual course Fee Regulations for details.

Note 2a

For overseas students first registering prior to 2015/16: With the exception of students first registering on the GDAD or a stand alone pre-sessional English course, overseas students will pay, for the duration of uninterrupted studies (refer to the Fees Regulations for a full explanation of 'uninterrupted studies'), the fee rate in force in the year of first registration – these historical fee rates can be accessed on the University website. Therefore, the Overseas fee rates stated below apply to new entrants only. The fixed fee does not apply to students progressing to the MBA. Overseas students progressing directly from the GDAD course at UCA to a UCA Masters degree course will be entitled to a tuition fee discount of £1,000 in respect of the first year of that Masters course. This will be subtracted from the standard listed fee at the time of enrolment. To be eligible for this discount, students must enrol on the Masters course in the academic year immediately following completion of their international pathway course. There is no discount for students progressing from a stand-alone pre-sessional English course.

Note 3

We do not quote part-time overseas fee rates as overseas students may normally only obtain a student visa for full-time study. Where exceptionally we permit an overseas student to study in part-time mode the Registrar will determine an appropriate fee, based on the pro rata full-time fee rate.

Note 4

For courses which include a pre-sessional English component an additional tuition fee will be charged, as follows: £1,850 for the five-week course and £3,700 for the 10-week course.
