- 1 Scholarship applicants must apply for a scholarship at the same time as, or subsequent to, applying for one of the BSBI programmes.
- 2 All information provided in the application form will be considered when applying for the BSBI scholarship.
- 3 The scholarship amount is awarded at BSBI's discretion and constitutes a reduction in tuition fees payable to BSBI.
- 4 All the remaining fees must be paid according to T&C stipulated in the Programme Application Form Section 3, Programme Fees.
- 5 If you intend to postpone your place until the following intake, you will need to pay the remaining tuition fee. You will be permitted to do so only at the discretion of BSBI.
- 6 The scholarship is not transferable to another student.
- 7 In the event that a student does not attend a programme through serious unforeseen circumstances (death, accident, or serious illness) a specific committee will examine each case on an individual basis. Attendance is compulsory. An attendance rate of less than 90% will lead to scholarship withdrawal.
- 8 Any failure to start the course as scheduled without prior notification of the School's authorities will lead to scholarship withdrawal.
- 9 The scholarship is for the ONE named person and BSBI will not be responsible for a scholar's family members/spouse/children etc.
- 10 BSBI may also use information collected regarding the scholars in the School marketing activities; however, students' addresses and telephone numbers will not be given out without permission from the student via a request from BSBI.
- 11 BSBI may feature your interview/photo/profile/story on the BSBI website and/or other School publications and will ask for your permission/approval prior to publishing this.
- 12 Please note that when requested scholars are required to show originals (not photocopies) of transcripts and documents submitted in evidence with their scholarship application, and present these to the Scholarship office, if there is any question of authenticity. If BSBI discovers any documents that are NOT 100% genuine, the scholarship award will immediately be invalidated and withdrawn. The School accepts NO liability in this case.
- 13 It is the scholar's responsibility to set a good example, e.g. strive for best results, attend classes, finish the course on time and continue to demonstrate the exemplary student attributes/grades by which he/she was awarded the scholarship.
- 14 By invitation only, scholars will take part in welcoming new students to the scholarship programme.
- 15 The BSBI Scholarship panel will not provide information regarding the non-awarding of scholarships and the panel's decision is final.
- 16 The School reserves the right to investigate and possibly withdraw a person from the scholarship programme if there is adequate proven evidence of serious allegations of illegal activities.

Your Information – Our Fair Processing Notice to You

Data Controller
